This investor update provides Spirit's third quarter 2018 guidance. All data is based on preliminary estimates.

Total revenue for the third quarter came in more than \$25 million higher than the mid-point implied by our initial guidance. Total revenue per available seat mile (TRASM) for the third quarter 2018 is estimated to be 9.44 cents, up approximately 5.5 percent year over year compared to our initial estimate of up 2 to 3 percent year over year. Our strategic network re-orientation, better-than-expected results from improved yield management processes, and a strong operating environment all contributed to this outperformance versus our initial expectation.
